Decide to hire an apprentice

- Contact an Apprentice Connect Australia Provider (ACAP) for information and assistance
- Understand your responsibilities as an employer



Find an apprentice to hire

- This could be:
 - » An existing worker
 - » Someone you know or who is suggested by an ACAP
- Have a conversation and see if they want to work with you





Sign up your apprentice

Your ACAP will guide you through this process.

- Sign a national Training Contract with your apprentice and the nominated Registered Training Organisation (RTO)
- Once the training contract is registered, you will sign a training plan developed by the RTO



Support your apprentice

- Onboard your apprentice within your business
- Provide on-the-job training
- Supervise and mentor your apprentice
- Monitor their progress against their Training Contract
- Release them for off-the-job training at the RTO
- Comply with all of your responsibilities as an employer

Sign them off

- Agree with the RTO and the apprentice that all required competencies have been attained for the qualification
- Your RTO will advise you on your responsibilities and formal requirements
- Sign training contract completion agreement
